## Historic Preservation Commission March 16, 2009 MINUTES

The meeting was called to order by the chair at 7:13 pm

Michael mentioned that there are many hamlets within the Town of Saugerties, Veteran, Fish Creek, High Woods, each worthy of Historic District designation.

4. Report on the meeting with Joe and Jeannette Sauer re possible designation of their barns adjacent to the Cockburn/Snyder house.

5. Setting of the public hearing date for Niger and Old Carriage Roads.

Josh Randall believes that since the law has been changed, the proposal for historic designation of the property should be re addressed.
