STREAM BUFFERS

WHAT IS A STREAM BUFFER?

Stream buffers are areas along rivers, streams, and other bodies of surface water that are designated by humans to help protect the water body.

WHY SHOULD THESE BUFFERS BE RESTORED AND/OR EXPANDED?

Expanding stream buffer areas and restoring vegetation, especially native trees and shrubs, helps to store water during droughts and helps protect people and property from the impacts of flooding. Healthy vegetated stream buffers intercept rainfall, filter runoff, capture sediment, absorb excess floodwaters, provide shade (which reduces water temperatures), and reduce erosion.

Restoring vegetated buffers is important in flood-prone areas, but also in upstream areas to reduce the speed and potentially the volume of floodwaters. Healthy stream buffers also offer habitat benefits and contribute to ecosystem resiliency.

Hudson Estuary Trees for Tribes provides free native New York seedlings to help protect streams, which in turn:

- *Protects water quality*
- *Reduces erosion and flooding*
- *Creates fish and wildlife habitat*

WHERE:

Property along streams and waterways within the Hudson River Estuary Grant Program boundary in Orange and Ulster Counties.

WHO CAN APPLY FOR FREE TREES?

- Landowners
- Property managers (in partnership with the landowner/s)
- Municipalities, community groups, and non-profit organizations (with permission from the landowner)

HOW MUNICIPALITIES CAN HELP

TAKE THE LEAD: Partner with local conservation advisory councils, civic groups, and other entities on a Hudson Estuary Trees for Tribes planting in your community. If your municipality has a tree commission, encourage one of its members to serve as a liaison for the this program. This individual/s would be tasked with identifying and helping to implement a potential project.

SPREAD THE WORD: Engage the community about this important program by utilizing the provided content on pages 4-5.

COMPLETE A MUNICIPAL RIPARIAN ASSESSMENT: Complete a riparian assessment as part of Climate Smart Communities! This assessment identifies and prioritizes sites for conservation and revegetation of buffers.

HOST A TREE PLANTING: If your municipality owns property that may qualify for Hudson Estuary Trees for Tribes, Ulster County Soil & Water Conservation District staff can help determine your eligibility. [Contact us](#) to get started!

Landowners with property along streams and waterways may be eligible for free trees and shrubs through the Hudson Estuary Trees for Tribes program. This vital program aims to stabilize streambanks, reduce erosion, and mitigate flooding issues, while protecting water quality and enhancing habitat for fish, birds, and pollinators.
