 Winnie, Derek Saugerties Self Storage 2307 Rt. 32 Saugerties, NY 12477

- -Property located at 2307 Rt. 32
- -Property zoned General Business with Gateway Overlay
- -Mr. Richard Praetorius from Praetorius and Conrad was present at meeting to represent the applicant Mr. Derek Winnie.
- -Mr. Praetorius explained was what submitted to the Zoning Board from his office and asked the Board if they wanted further clarification.
- -Jeanne asked the Board if they had any questions for Mr. Praetorius. Donn asked a question regarding the letter submitted by Praetorius and Conrad specifically #4 wouldn't the hardship be for everything in that zoned area and reasoning is because hardship created because of rezoning. Mr. Praetorius said Mr. Winnie was permitted in 2004 to build the Self- Storage Units and in 2008 when the rezoning was done it was now against zoning and with most self-storage units you build, fill, then expand and continue the process and now he cannot. Mr. Praetorius went on to say how in 1989 when zoning was created by the Town of Saugerties that the Town Board allowed for pre-existing businesses to have the ability to get on a list stating that their businesses were there before zoning was created hence having the ability to stay the way they are and to expand if they wished. But in 2008 when the zoning was changed again for some areas that luxury was not given to the businesses that would be affected by the re-zoning. Jeanne made mention that that is something he would have to take up with the Town Board not the Zoning Board.
- -Jeanne stated that she does not agree with 3 of the 4 points made in the letter submitted by Praetorius and Conrad.
- -Alvah Weeks, Building Inspector, made mention that should Mr. Winnie like he should speak with the Town Board and get on the Pre-existing business list and then come back to the Board and try to get this variance approved. Jeanne felt that was ok but should talk with the Town Board. The remaining Board of Appeals likes this idea.
- Henry agrees with Alvah's point saying people now should be given the opportunity those in 1989 had.

Winnie Cont'd:

- -Jeanne made mention that if you proceed with a Use Variance it is a difficult process and that all four (4) requirements MUST be met and as of right now she sees only one being met so that would be an automatic denial.
- -Mr. Praetorius is not a fan of Use Variances but he feels that the Town Board route will be the best route.
- -Mr. Leighton was at the meeting and he stated that he will bring it to the Town Board once he gets word from the applicant that he wants to proceed.
- Jeanne asked how he would like to leave this appeal Mr. Praetorius said he is officially asking that the appeal to be put on hold and please not schedule the Public Hearing until further notice.
- Appeal ended at 7:45pm.
