PRIVILEGE OF FLOOR:

Spider Barbour gave the Shokan Reservoir and Esopus Creek reports. There is a new brochure available, Lower Esopus Creek, available at town hall. NYC needs to maintain clean, natural water. They have no water filter system. There are two ways to get rid of the mud, float or sink – not acceptable drinking water. Kensico Reservoir uses Allum, DEC says you can only use so much Allum so instead they are sending the water down to the lower Esopus to us. The discussion continued.

Greco, Esq., as attorney for the Town of Saugerties, to settle the pending real property tax assessment review proceeding in the matter of Deluxe Packaging corp. vs Frank Orlando, the Assessor the Town of Saugerties, et al.

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to allow the Town of Saugerties to make a request to the New York State Department of Transportation for parking restrictions at the intersection of Glasco Turnpike and Route 32.

Discussion: Supervisor Helsmoortel added that we did this a number of months ago and received prices and didn't purchase but we may do it again.
