- Appeal started at 7:05pm.
- Stanley Ostrander, contractor, present for applicant.
- The property is located at 714 W. Saugerties Woodstock Rd. and is zoned MDR (moderate density residential)
- Applicant is requesting a 10' side yard area variance to construct a one story one car garage 18' x 24'. 25' is needed per zoning and the applicant only has 15'.
- There is no other feasible location for the construction of the garage, as per the contractor.
- The owner wants to use the existing driveway and entrance into the house that is why he would like it built where proposed.
- Septic is located on the other side of the house which will be an issue if built there.
- There is also a water issue in the basement on the side of the house where the garage is to be constructed and the addition of this garage will hopefully alleviate that problem, as per the contractor.
- There is a glass structure attached to the house where the garage is to be constructed and the board asked if it is to be removed and the contractor was unsure at this time.
- Jeanne explained that the next step is a public hearing and then after that the board will have 62 days to make a decision.
