Kevin Brown, Building Inspector – gave the monthly report, which is on file at the Town Clerk's

**BOARD COMMITTEE REPORTS:** 

Councilwoman Nau – Historic Preservation Commission held a Public Hearing on 09/19/22.

Councilwoman Thornton – TV 23 will air shows with the Chief of Police on the first and third Fridays; CPC is updating the zoning and Library is collecting food pantry items from September 1<sup>st</sup>, through October 15<sup>th</sup>.

Councilman Ivino – Property Maintenance Law is in full effect and has already cleaned up abandoned vehicles by Herricks Bridge.

Motion made by Councilman Ivino, seconded by Councilwoman Thornton to set a public hearing for October 5, 2022 at 6:30 p.m. pertaining to a Restore NY Grant for rehabilitating properties.

Discussion: Supervisor Costello thanked Kevin Brown and Kathleen Gray for working on this.

Motion made by Councilwoman Nau, seconded by Supervisor Costello to approve the proclamation, as on file, regarding Diana Balling.

Motion made by Councilwoman Thornton, seconded by Supervisor Costello to approve the Memorandum of Agreement, as on file, between the Town of Saugerties and the International Brotherhood of Teamsters Local Union No. 445.

Motion made by Supervisor Costello, seconded by Councilman Ivino to approve the resolution, as on file, Ecological Restoration Grant pertaining to a pollinator garden.

Vote: Adopted – 4 Yes (Councilman Horton absent)

Motion made by Councilman Ivino, seconded by Supervisor Costello to approve adding Suzette Perry to the Parks & Buildings part time call out list at a rate of \$20.00/hour, per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 4 Yes (Councilman Horton absent)

Motion made by Councilwoman Nau, seconded by Councilwoman Thornton to approve hiring Megan Carney as a full time Permanent Court Clerk at a rate of \$17.00 per hour, effective October 5, 2022.

Vote: Adopted – 4 Yes (Councilman Horton absent)

Motion made by Councilwoman Thornton, seconded by Supervisor Costello to approve a transfer of \$91,000.00 from the American Rescue Plan Act (ARPA) COVID relief fund into the Police Department's Budget under Line A3120.100 (Salary Line) as per the agreement between the Town of Saugerties, the PBA, and CSEA employees of the police department by which the town agreed to give each eligible employed.

Motion made by Supervisor Costello, seconded by Councilman Ivino to approve KD Environmental Consulting LLC, 2 Hagan Drive, Poughkeepsie, NY 12603, owner David French, as a Certified Energy Code Compliance Inspector per the International Energy Conservation Code.
