Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to set Public Hearing dates of May 4, 2011 at 6:30 p.m. and May 18, 2011 at 6:30 p.m. at the Frank D. Greco Multi Purpose Building to discuss application for US Department of Housing (RUPCO) grants.
