

PLANNING BOARD MINUTES

JUNE 15, 2004

Eight public hearings were scheduled for this meeting and the public was invited to come forward to examine maps and ask questions. William Creen, Chairman, opened the meeting at 7:43p.m. Present for the meeting were William Creen, Howard Post, James Bruno, George Collins, William Brandt and John Rinaldo. Absent was Carole Furman. Stuart Mesinger from Chazen was present.

A motion by Brandt, seconded by Post to accept the Minutes of May 2004 with correction. All in favor, none opposed, carried.

5. Site Plan-Rothe Manure Composting Facility-Malden Turnpike-Maps presented by Richard

Rothe-transferring manure from H.I.T.S to Rothe property on Malden Turnpike. Has a 1 acre slab pre-existing. Manure will be processed by composting for 1 to 3 years then sold. Manure will be 75% sawdust and hay. Concerns are drainage - run-off especially with issue of the pond. If slab gets covered, then issue of pond goes away. Needs drainage plan. Suggested pole barn over slab but expensive. March Gallagher, attorney for Mullen/Rothe suggested a tarp, but would cause to much heat. Discussed drainage being pumped back on pile, this helps break it down faster, too. Concerned with odor. Creen will give Rothe a name for consulting.
