- Richard Rothe attended meeting to represent Kris Rothe.
- Board asked Richard if all was the same with the appeal still, Richard said yes all is the same still seeking an area variance for the single family residence with the apartment.
- Public Hearing was scheduled for March 7, 2011 at 7pm.
- Richard was given mail out list for the neighboring properties located within 500' of above referenced location.
- Joe Roberti, Sr. made motion to classify this project as SEQR TYPE II 617.5(c)(13) Area Variance for Residences; 2<sup>nd</sup> by Henry and 3<sup>rd</sup> by Brian. Vote taken, all in favor; 4-0.

Voda, Candace 368 Hommelville Rd. Saugerties, NY 12477

Property located at 368 Hommelville Rd.

- -Discussion opened by Joe Roberti, Sr. on the decision for Candace Voda's appeal.
- Brian stated that he would decline to approve the requested variance because it was built without obtaining a permit that the variance being requested is very substantial and she has other places on her property to put the structure.
- Henry stated that he feels the same as Brian however, he see that it is not uncharacteristic of the neighborhood but that there is plenty of other places to place the carport.
- Joe M. shares both points of view made by Brian and Henry however, he would be inclined to grant the requested variance with a stipulation that it be moved to 4' off the property line and have a new survey map issued to prove that it is the 4' off the property line.
- Brian made the motion to deny the requested appeal due to it being a significant variance and that there are other feasible locations to place the carport, motion 2<sup>nd</sup> by Joe R. Vote taken, 4-0, therefore, the motion is passed and the request is denied.
