OLD BUSINESS:

- 1. Site Plan and Special Use Permit Michael Persico / John Hommel Rt. 32N- Plans presented by John Hommel. Plans to store construction materials and store existing antiques in building. Stock piles of construction material. Needs a landscaping plan to screen piles due to 30ft. from Rt. 32. The ROW that runs through the middle of parcel needs to be open and unobstructed at all times. Needs a NOTE on the plan to state the same. Does not plan to improve the road. Forward to UlCoPlBd when complete along with a landscape plan. A motion by Goldberg, seconded by Furman to schedule a public hearing for February 19, 2013. All in favor, none opposed, carried. A motion by Goldberg, seconded by Tiano to forward the site plan and landscape plan to UlCoPlBd. All in favor, none opposed, carried. No other motions will be made until February Meeting.
